Hello,

Recently we have had a few Australian packages sent to the genetic testing service be stopped by the CDC quarantine import station at the Miami, FL port. To minimize any packages being prohibited from entry in the United States, we have included a new Certification Statement of Non-Infectiousness (the second import form). If you are able to get a veterinarian sign-off for the health of your animals, that would be greatly appreciated, as it follows the guidelines CDC sent to us when the shipment was halted. We understand that many of our clients sample their animals at home and may not see a veterinarian before sending samples off, however, we felt the need to inform you that there is a possibility the package will be stopped without the statement of non-infectiousness. We apologize for any confusion or complications, we are just trying to accommodate international packages as best we can while still following import regulations. Dear valued customer,

The USDA and CDC have issued guidelines for importing feline material into the United States. To ensure timely delivery of your samples, we recommend following these instructions:

1. Two declaration statements have been included in this package. Please read over the declarations to ensure all of the statements are correct regarding your samples.
2. Sign and date the declaration statement. The second form will require sign-off from a veterinarian.
3. Place the statement into the envelope we have provided for you. Do not seal the envelope.
4. Indicate on the outside of the envelope that "Import Declaration for Feline Material are included in this envelope".
5. Attach the unsealed envelope to the outside of your package.
